With its unique appearance and touch dimmer switch the Dual Color LED awning light is ideal to be mounted to campers, caravans RVs and canopies. Available in 3 different configurations and featuring super bright wide-angle LED chips, to create a wide dispersed light while drawing very minimal current. The touch switch easily controls the on / off functions while maintaining a fully waterproof IP67 rating.

# **Operation Instructions:**

- Connect to power source.

- The light has a memory function and will revert to the previous colour & brightness settings if power is lost and restored.
